## Revised! – OSHA's Beryllium Standard for Construction & Shipyard Sectors

Effective date: September 30, 2020

The <u>final rules</u> for 29 CFR 1926.1124 and 29 CFR 1915.1024 seek to clarify certain provisions and simplify or improve compliance. The Occupational Safety and Health Administration (OSHA) notes the revisions are designed to: (1) more



appropriately tailor the requirements of the construction and shipyards standards (2) aid in compliance and enforcement of the standards; and (3) clarify requirements with respect to materials containing only trace amounts of beryllium. The below table provides a summary of changes to review.
